POLICY NAME

Club House Rules

PURPOSE

The purpose of this policy is to set out the rules for use by members of Torquay Surf Lifesaving Club (the Club) facilities generally.

- The Club Captain has oversight of building use by members. The Director of Facilities is responsible for coordinating maintenance & repair of club facilities.
- It sets out the limitations on access and the responsibilities of members who use the club facilities.

SCOPE

This policy applies to all members, officers, directors and employees of Torquay Surf Life Saving Club.

This policy applies to all visitors and guests of members.

POLICY

1. Conduct likely to interfere with the comfort of other members of the Club shall not be tolerated and members are requested to assist in preventing such conduct.
2. The club should be maintained in a clean and tidy state at all times, with members endeavouring to leave areas cleaner and tidier than prior to their use.
3. All damage, whether caused by the member or otherwise identified, must be immediately advised to the Responsible Director.
4. Damage occasioned to the club house facilities shall be subject to investigation and decision of liability by the TSLSC Board.
5. Wetsuits are not to be worn within the main hall or members' lounge.
6. Bad language shall not be tolerated in the club house.
7. Animals shall not be allowed in the club house, with the exception of registered assistance animals.
8. Liquor may only be consumed in the club house at an organized function approved by the committee.
