POLICY NAME

Private Equipment Storage & Transport

PURPOSE

The purpose of this policy is to set how personal equipment may be stored within club premises and transported by the club.

- This policy relates to the storage and transport of private equipment, including setting out limitations of responsibility and liability.
- Equipment may be stored in the club, at the sole risk of the owner.
- Equipment may be transported by the club, at the sole risk of the owner. It is the responsibility of the owner to adequately secure equipment ready for transport.
- The club bears no responsibility or liability for the security or securing of private equipment and does not hold insurance to cover loss or damage.
- No claim can be made against the club or any individual for theft, damage or loss.

SCOPE

This policy applies to all members, officers, directors and employees of Torquay Surf Life Saving Club.

POLICY

- 1. Storage of Equipment
 - a. The Club has limited space in the "craft shed". Craft storage is not a right of membership, but a privilege afforded to members of good standing and subject to the restrictions set out in this Policy.
 - b. An annual fee of \$250 will be charged to people wishing to store craft who are not:

- And those the Directors see fit to grant an exemption in writing.
- c. All personal equipment and craft stored within the Club facilities is done so on the understanding that all liability for theft, damage or loss is at the owner's full responsibility.
- d. Members are strongly recommended to hold their own insurance for private equipment stored on the club premises.
- e. Members should not use the craft storage sheds as changes rooms. Changing should only be undertaken in the change rooms provided by the Club. No bikes, bags or other personal items should be left unattended or stored in the craft storage sheds.
- f. The Club assumes no liability for personal craft stored or personal items left on the club premises.
- g. Equipment stored within the club shall not be used other than by the owner, without the express prior permission of the owner. Breach of this item shall be considered a disciplinary matter.

2. Transport of Equipment

- a. The Club may from time to time arrange for private equipment transport to be made available to members attending events.
- b. This may be on vehicles and/or trailers and/or other modes of transport;
 - i. Owned by the club
 - ii. Operated by the club
 - iii. Organised by the club
 - iv. Sanctioned by the club
- c. All personal equipment and craft transported in accordance with this section is done so on the understanding by the member that all liability for theft, damage or loss is at the owner's full responsibility.
- d. Members are strongly recommended to hold their own insurance for private equipment transported by the club.
- e. For the avoidance of doubt, the securing of equipment ready for transport is the sole and non-transferrable responsibility of the owner. The club does not provide a securing service and takes no responsibility for the placement or securing of any equipment being transported.
- f. In the event of theft, damage or loss of transported equipment, no claim can be made against the club, the operator (if that operator is a private individual) or any member of the club or an affiliated organisation.
